

PRIVACY POLICY

Updated August 2024

Didsbury Theatre School (DTS) complies with General Data Protection Regulation (UK GDPR) and the Data Protection Act of 2018.

DTS agrees to:

- 1. Be open and honest with all service users from the outset about why, what, how and with whom information will, or could be shared, and seek their agreement, unless it is unsafe or inappropriate to do so.
- 2. Seek advice if in any doubt about how to use information, without disclosing the identity of the person where possible.
- 3. Where possible, share with consent and respect the wishes of those who do not consent to share confidential information. You may still share information without consent if, in your judgement, that lack of consent can be overridden in the public interest. You will need to base your judgement on the facts of the case.
- 4. Consider safety and well-being: Base your information sharing decisions on considerations of the safety and well-being of the person and others who may be affected by their actions.
- 5. Necessary, proportionate, relevant, accurate, timely and secure: Ensure that the information you share is necessary for the purpose for which you are sharing it, is shared only with those people who need to have it, is accurate and up-to-date, is shared in a timely fashion, and is shared securely.
- 6. Keep a record of your decision and the reasons for it whether it is to share information or not. If you decide to share, then record what you have shared, with whom and for what purpose.
- 7. Ensure the school's 'Privacy Notice' is freely available to all new members.
- 8. Audit the Data Protection Policy and Privacy Notice annually.

PRIVACY NOTICE

This privacy notice explains how and why we Didsbury Theatre School (DTS) process your personal data under the General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

It tells you what DTS may do with your personal information when you join us or use one of our services.

Who we are

The Didsbury Theatre School (DTS) acts as the data controller for the purpose of Data Protection Law.

When do we collect personal data?

We collect personal data when you:

- Join our school as a parent or carer
- Join our school as a student
- Join our school as a teacher
- Book one of our events, holiday camps, courses or performances
- Sign up to our e-newsletter
- Respond to a survey or online form
- Visit us and/or speak to a member of staff or a volunteer

The term 'personal data' is any information relating to an individual.

We only process data containing personal information for the purposes of: staff administration (including payroll); accounts; records; advertising, marketing and public relations in connection with DTS.

We collect and use personal data in order to give our members the best possible experience of DTS. We are committed to being honest and respectful in collecting and using all personal data.

What personal data do we collect?

The type of information we collect depends on the reason for your relationship with us. We may collect and hold:

- your full name
- · your contact information including email address, telephone number and postal address
- your contact preferences
- relevant medical information to ensure we can meet health and well-being needs
- financial information
- transaction and order details
- demographic information
- still and moving images taken during your visit
- other information relating to surveys or feedback
- alumni information including photographic images taken during your training here at DTS

We do not collect special category personal data from our members relating to health, race, religious beliefs and political opinions unless there is a clear reason for doing so, such as

protecting children from harm, or providing additional access requirements at an event, course or performance. We only use this information to ensure we provide the best possible level of service.

How we may use your personal data?

We always endeavour to be fair and transparent with how we use your information and ensure at all times that your information is protected.

The personal data you provide may be used:

- to provide a service or fulfil a purchase
- to process payments by debit/credit card or by setting up direct debits
- for fundraising purposes
- for alumni purposes
- to invite you to participate in relevant surveys
- for marketing purposes when specific consent has been given
- to better understand your preferences in order to tailor our communications to suit your interests
- to analyse and improve the services we may provide
- to act in accordance with the DTS Safeguarding Policy

We will not hold more information than required and will ensure all personal data held is kept up to date and used only for its specific purpose(s) outlined above. The retention policy will vary according to the purpose and may be contingent on circumstances when required to keep the data on the grounds of legal obligation and legitimate interest. Please email admin@didsburytheatreschool.co.uk for further information on how long we may keep your data.

We will not sell, rent, trade or distribute your personal data to any third parties for marketing purposes unless we have received your prior permission to do so. Data may be shared with trusted service providers who are authorised to act on the school's behalf and have entered into data processing agreements with us. These services may include payment processing, event ticketing, database services, website hosting and email delivery services. In these circumstances, your data will only be used for the agreed purpose relating to the service that they are providing. Occasionally promotional photos or videos of your child may be used by The Children's Theatre Group or other schools within the group. This is with prior written consent (on the DTS Registration Form).

We do not transfer any personal data to countries outside of the European Economic Area (EEA).

Legitimate interest

We may occasionally hold or use personal data on the grounds of 'legitimate interest'. In broadest terms, this means that we can process personal information if we have a genuine and legitimate reason, and we are not harming any of your rights and interests. Before using this basis, we carefully consider and balance any potential impact on you and your rights.

How do we protect your personal data?

All information you provide to us is stored on our secure servers and in files which are locked

away. Any personal information retained is kept confidential and stored in a secure, password protected, database that is only accessible by relevant members of staff.

We will take appropriate technical and organisational steps to ensure the security of personal data about individuals, and access to school systems. All staff are aware of the Privacy Policy and their duties under Data Protection Law and continue to receive relevant training.

Your Rights

Wherever you are asked to submit personal data there will be an option for you to select the type of communications you wish to receive, and in some cases how you wish to be contacted. You have the right to update your preferences at any time by contacting us at admin@didsburytheatreschool.co.uk

The accuracy of your personal data is important to us and you have the right to update the personal data that we hold. Please help us keep our records up to date by notifying us when your personal data changes by contacting admin@didsburytheatreschool.co.uk

If you ask for your data to be removed, we will keep the minimum amount of information to ensure we adhere to your request. Please note however that we may have a lawful reason to hold or use the personal data in question which does not require consent.

You have the right to ask us not to hold or use your personal data however this does mean we may not be able to provide you with the full range of services that are offered.

Under the Data Protection Act 1998, or after 25 May 2018, the General Data Protection Regulation, you have the right to request full details of your personal data that is held by us. To make this request please email admin@didsburytheatreschool.co.uk including a description of the information you would like to see together with proof of identity.

We will update this notice from time to time. Any substantial changes that affect your rights will be provided to you directly as far as is reasonably practicable.

If you have reason to believe that we have not complied with this notice, or acted otherwise than in accordance with Data Protection Law, please utilise the school complaints procedure and email admin@didsburytheatreschool.co.uk. The school can also make a referral to or lodge a complaint with the Information Commissioner's Office (ICO), although the ICO recommends that steps are taken to resolve the matter with the school before involving the regulator.

Data Protection Policy - Summary

At Didsbury Theatre School we firmly believe that your personal information belongs to you and as such the privacy and security of that information is of paramount importance to us. Our aim when collecting this information is to serve you better and provide a more professional service. We will not rent or sell your information to third parties and we will always process your Personal Data in accordance with the law, in particular with the UK Data Protection Act 1998.

What we do with your data:

At Didsbury Theatre School, we only process data containing personal information for the purposes of: staff administration (including payroll); accounts; records; advertising, marketing and public relations in connection with Didsbury Theatre School.

Advertising, marketing and public relations:

We hold personal data for the purposes of advertising or marketing and promoting public relations in connection with the activities and services relating to Didsbury Theatre School.

The individuals we hold information about is restricted to any person whose personal information we need to process for our own advertising, marketing and public relations, including past, existing or present customers or suppliers. This information is restricted to information that is necessary for our advertising, marketing and public relations, for example names, addresses and other identifiers. Our disclosures (except those made with the data subject's consent) are restricted to those that we must make to third parties for purposes of our advertising, marketing and public relations.
